## ITEM 4 – ORAL COMMUNICATIONS TO THE BOARD

# ITEM 6 – DISCUSSION/ACTION REGARDING GATEWAY IRWM PROP 84 GRANT FUNDING AND IRWM PLAN UPDATE

Ms. Grace Kast provided an update on the Gateway IRWM Prop 84 grant funding and IRWM Plan. She indicated that DWR had sent out a summary of applications received for the Drought Grant program. She stated that 39 grant applications were received and stated that a maximum of \$96 million was assigned to our funding area. She stated that GWMA's application requested \$6.7 million and \$27 million was requested by the Greater Los Angeles IRWM group. She also stated that this \$96 million included the final round funding which was expected in 2015.

Ms. Kast stated that \$339 million was requested statewide, but only \$200 million would be allocated.

# ITEM 7 – PRESENTATION: PROPOSED RULES/CLARIFICATION REGARDING U.S. DEFINITION OF RECEIVING WATERS (JOHN HUNTER)

Mr. John Hunter, John Hunter & Associates, provided a presentation with regard to the proposed rules/clarification regarding the U.S. definition of receiving water. He stated that this had been a very contentious and confusing issue for decades. He proceeded to provide a definition of what is classified as "Waters of the United States" and that there have been back-and-forth rulings and determinations for many years regarding this definition. He stated that the USEPA has now been directed to clarify the issues. He reported that the deadline to submit comments on this issue was October 20, 2014 and stated that the RWQCB was not aware of any eminent plans at the local or state level to clarify the definition for the Los Angeles area.

After general discussions, the Board directed staff to draft a comment letter to be sent as a group and bring it back to the Board at its next meeting for review/approval.

The Board also directed staff to email a copy of Mr. Hunter's presentation to all Board and Alternate members.

# ITEM 8 – DISCUSSION/ACTION TO CONSIDER SERVING AS FIDUCIARY/CONTRACTING AGENCY ON BEHALF OF THE DOMINGUEZ CHANNEL GROUP TO COMPLETE A COORDINATED INTEGRATED MONITORING PROGRAM

Ms. Kast reported that GWMA received a request from the Dominguez Channel Watershed Management Area Group to serve as the fiduciary/contracting agency on their behalf to complete a Coordinated Integrated Monitoring Program. She indicated that the only GWMA member that was a member of this Watershed Group was the City of Long Beach.

After detailed discussions, Director Pelser moved to direct staff to contact the Dominguez Channel Watershed Management Area Group to notify them that GWMA would consider acting as its fiduciary/contracting agency pending final approval by the GWMA Board of an MOU. ITEM 9 – APPROVAL OF AN AGREEEMENT TEMPLATE BETWEEN GWMA AND AN INDIVIDUAL, PRIVATE NPDES PERMIT HOLDER FOR COST SHARING FOR THE IMPLEMENTATION OF A COORDINATED COMPLIANCE MONITORING AND REPORTING PLAN FOR THE DOMINGUEZ CHANNEL AND GREATER LOS ANGELES AND LONG BEACH HARBORS WATER TOXIC POLLUTANTS TMDL

Ms. Kast reported that the Harbor Toxic Pollutants TMDL Group was requesting administrative assistance from GWMA in the form of an agreement between GWMA and individual, private sector NPDES Permit Holders for cost-sharing purposes. She stated that the Harbor Toxic Pollutants TMDL Group consisted of the cities of Bellflower, Lakewood, Long Beach, Paramount, Rancho Palos Verdes, Rolling Hills, Rolling Hills Estates, Signal Hill, County of Los Angeles, Los Angeles County Flood Control District, Port of Los Angeles, and the Port of Long Beach. She stated that the fiscal impact was anticipated to be zero dollars to GWMA and indicated that the Harbor Group and individual Permit Holders would pay for GWMA's staff time for hiring consultants. She indicated that legal fees would be billed directly to the Harbor Group and individual Permit Holders.

Ms. Kast stated that the Agreement template, which was similar to the MOU between GWMA and the Harbor Group and other WMP related MOUs, reflected the input of the Harbor Group, GWMA's Legal Counsel, and staff review.

Director Alvarez moved to approve the Agreement Template and authorize the GWMA Chair to approve and execute individual agreements between GWMA and each individual NPDES Permit Holder, to the extent that individual NPDES Permit Holders do not request revisions to the Agreement Template and that any requests for revisions be brought before the Board for consideration. The motion was seconded by Director Nila and approved by the following voice votes:
